# 2. Presentation: Slow It. Spread It. Sink It. Store it!— Keith Abeles, Water Resources Program Manager, Sonoma Resource Conservation District

- Keith Abeles described the goals and coverage area for the Sonoma Resource Conservation District (SRCD). The Slow It, Spread It, Sink It! document, which encourages and guides residents on how to manage and utilize stormwater as a resource, was recently updated. There were two main changes to the document: 1) "Store it!" was added to the end of the title and related storage practices were added to the guide; and 2) the resources section was substantially enhanced. The latest version of the guide is available online as a PDF.
- Ann DuBay (SCWA) asked whether permitting issues are addressed in the guide. Permitting constraints are addressed in the guide and there are many links to outside resources for further information. There is also an external one-pager that addresses permitting issues and resources.
- There was discussion on how well the SRCD's recommended practices line up with Low Impact Development (LID) practices. In general, the concepts are related and they do not conflict with each other. The main difference is that this guide is intended for voluntary residential projects, and LID has strict requirements for municipalities and developers.
- Keith Abeles addressed project funding. This document update was completed
  without grant funding. Because of this, the Slow It, Spread It, Sink It, Store It!
  Guide was not printed for distribution and is only available electronically. Andy
  Rodgers (RRWA) discussed the potential for an RRWA partnership for a bulk
  purchase of guides and/or flyer that points people to the online PDF.
